What data does Buckminster Road Baptist Church collect?

Here's the data we collect from you on our website:

- Personal identification information (Name, email address, phone number, etc.)
- Any other information you provide via the Contact Form on this website, or by emailing us directly

In summary, we don't collect very much when you're interacting with us online.

How does Buckminster Road Baptist Church collect your data?

You directly give us most of the data we collect. We collect and process data when you:

- Fill in the Contact Form on the website
- Use or view our website through your browser's cookies
- Email us directly

How will Buckminster Road Baptist Church use your data?

We collect your data so that we can:

- Use Wix Analytics to see how our site is being used, so we can improve its layout, performance, and content in the future
- Get back to any enquiries you make through the Contact Form on this website

How does Buckminster Road Baptist Church store your data?

We securely store your data in the Wix.com servers which support this website, and in the Wix Analytics platform which receives anonymised data about the way you use the website. Any applications or enquiries we receive will also be stored in our secure email servers from Google and Microsoft.

Buckminster Road Baptist Church will keep your personal data for 1 year, or as long as we continue to engage in business or communication with you. Once this time period has expired, we will delete your data by removing it from the Wix.com and Google email servers. It will automatically be deleted periodically from Wix Analytics.

Use of Cookies

Cookies are small pieces of data stored on a site visitor's browser. They're typically used to keep track of the settings users have selected and actions they have taken on a site.

We use cookies for important reasons, such as:

- To provide a great experience for our visitors, customers, and supporters
- To monitor and analyze the performance, operation and effectiveness of our website and the Wix platform it's built on
- To ensure our website is secure and safe to use

What are your data protection rights?

We want to make sure you're fully aware of all of your data protection rights. Every user is entitled to the following:

- The right to access – You have the right to request Buckminster Road Baptist Church for copies of your personal data. We may charge you a small fee for this service.
- The right to rectification – You have the right to request that Buckminster Road Baptist Church correct any information you believe is inaccurate. You also have the right to request Buckminster Road Baptist Church to complete the information you believe is incomplete.
- The right to erasure – You have the right to request that Buckminster Road Baptist Church erase your personal data, under certain conditions.
- The right to restrict processing – You have the right to request that Buckminster Road Baptist Church restrict the processing of your personal data, under certain conditions.
- The right to object to processing – You have the right to object to Buckminster Road Baptist Church's processing of your personal data, under certain conditions.
- The right to data portability – You have the right to request that Buckminster Road Baptist Church transfer the data that we have collected to another organization, or directly to you, under certain conditions.
